- PIT and HIC Date: MONDAY, January 24th....MAYBE???
 - HUD issued guidance today indicating CoC's could request a waiver to move the unsheltered PIT to the last ten days of February.
 - Unclear if this waiver would also apply to to the sheltered PIT and HIC.
 - Monday, February 21st would be the alternate day for whatever is moved.
- No public unsheltered count due to COVID risk.
- Outreach teams will be conducting unsheltered count throughout the week using a survey model.
- Revising sheltered PIT and HIC questionnaires to streamline them.
- Recorded training on how to complete forms will be made available ahead of PIT and HIC date.
- Shorter deadline for form submission with goal of quicker follow up.
